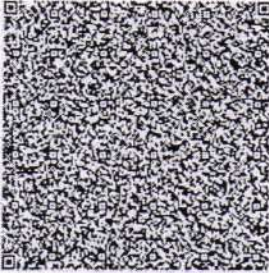

AIMS AND OBJECTS OF THE TRUST :




- j) To translate, print, publish and circulate books, Journals, Magazines and other periodicals.
- k) To setup libraries, Reading rooms and other study circles.
- l) To establish and run training institution for Advancement of the Indian cultural and fine Art.
- m) To undertake and carry out any other necessary steps, to promote the aims and objects said herein above.

II. POWERS AND FUNCTIONS OF THE TRUST :

- a) The trust shall open take over, establish conduct, maintain, manage, equip, handover, transfer, close down and dispose of the institutions, other related institutions, to promote the aims and objects of the trust.
- b) They shall engage, appoint, remove teaching and non teaching staff, express and advisors and other staff for the said institutions under the Trust.
- c) The trust can acquire, hold, purchase, create, lease, mortgage, gift, grant loan, create legacy, bequest, exchange, release or otherwise from any person, company, society, Govt. institution, organisation and Trust or by any body, whatsoever movables and immovable properties of all description deemed necessary useful for any purpose of the trust.
- d) The trust erect buildings or structures, whatsoever to further any purpose of the trust and to maintain develop, improve, alter, repair, demolish or reconstruct the same or any portion thereof.
- e) The trust can take or receive any gifts or donations whether money or property movable or immovable, donations in the form of debentures, stocks, shares or securities in any company or society whether incorporated or not or whether by way of gifts by a person living or by legacy, bequest, will or foundations and whether to any special trust or works connected therewith and to take steps for the securing of such contributions for funds towards corpus as from time to time be deemed expedient.
- f) Alienate by way of sale, mortgage, lease, release, loan, charge, hypothecation, properties of funds of the trust or any portion or portions thereof including the making or giving of subscriptions, contributions, assistance pecuniary or otherwise to such institutions, bodies or persons as from time to time deemed necessary.

C) CO-OPERATING OF NEW TRUSTEE :

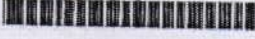

D) VOTING POWER OF THE TRUSTEE :

Every Trustee of the board of the trust shall have voting power of one Vote only. Author of the trustee will be the chairman of the board of the trust shall have a casting vote in case of equal votes. The author of the trust will have the veto power to vote any decision taken by the trust within one month period of such decision.

IV. VACATING THE OFFICE OF THE BOARD OF TRUSTEES :

The office of the trustee is vacated when :

- He dies
- Resigns
- Become Bankrupt or insolvent
- Become lunatic
- Neglect to take interest continuously for a period of more than three months
- By discharge of trustees by the author or chief promotions of the trust
- The office of the author of the trust shall be succeeded anyone of the remaining trustee by way of election among the trustees.

V. BENEFICIARIES OF THE TRUST :

The board of trustees will be the beneficiaries of the trust, entitled for the benefit arising out of the trust and properties.

However the educational benefit within the purview of the aims and objects of the trust will not confined to the board of trustees and their family members and the same shall be extended particularly to the Muslim minorities including the students of the other communities.

VI. MEETING OF THE BOARD OF TRUSTEES :

- The Board of trustees shall meet atleast once in a three months to transact the business of the trust.
- Seven days notice shall be given to the trustees of such meeting.
- In case of urgent matter they may be decided by circulation among the trustees. However unless such matter shall be ratified at the immediate meeting of the Board of Trustee.
- The Quorum for the meeting of the board trustees shall be 2/3rd number of trustees.

VII. POWER OF THE BOARD OF TRUSTEES :

1. The trustee shall set jointly carry the aims and objects of the trust and in case of any difference of opinion arises at any time themselves in doing anything or otherwise, the decision of the author shall be final.
2. The trustees shall not setup title adverse to the beneficial interest of the trust.
3. The trustees are bound to deal with trust property as carefully as a man of prudence, shall deal with such property as it its there own.
4. Whereas, the trustees commits breach of trust, he is liable to make good of the loss of which the property of the beneficiary has thereby sustained.

VIII. THE MANAGEMENT OF THE TRUST :

1. The management of the trust shall be vested in the board of the trustee. The trustees themselves or through duly authorized agent or agent employed by them shall manage and deal with the trust management in such manner as may be beneficial to the interest of the trust. And such agent be responsible for the custody of all records relevant to the trust and its properties and he shall be the chief executive officer of the trust.
2. The author of the trust may appoint one of the trustee as Managing Trustee and authorize him to sue or appear and defend the litigation or otherwise before the court of law, authorities, Board, Corporations on behalf of the trust.
3. The author of the trust may authorize the Managing trustee so appointed to execute the documents, relating to the trust properties whether movable or immovable and to secure or repay loan of the trust.
4. The author of the trust may constitute committees or sub-committees for the better management of the institution run by the trust and the said committees shall ceases to exist whenever the author of the trust deemed fit and the author of the trust shall be Chairman of such committees and in the absence of Chairman the members of such committees can select one of its members as Chairman for that particular meeting/occasionally only.

IX. AMENDMENT OF INSTRUMENT OF TRUST :

The Board of Trustees shall have the power to amend and later or rescind any of the clauses of the TRUST in a manner not in contravention of the aims and objects of the trust and interpret whenever the rules and regulation framed are not agreed by or in ambiguous provided that such change are interpretations do not conflict the aims and objects of the trust. If any difficulty arises in giving effect to the provisions of the "Instrument of the trust" the author of the trust may be circulation or otherwise make such provisions not in consistiting with the aims and objects of the trust as appears to be necessary for expedite for removing the difficulties.

X. SECRETARY :

Secretary shall be incharge of and responsible for safe custody of all records relating to the administration of the trust and its property.

He shall commence and call for the meeting of Board of Trustees under the direction of author/ President board of trustees and maintain the record of proceedings. All correspondence, financial statements, returns pertain to the management of the trust will be carried and be prepared by the secretary of the trust.

Secretary will be the employee of the trust and he will be appointed for a period of 2 Years purely on temporary basis. He can be absorbed only after ascertaining his satisfactory work and he will be chief executive officer of the trust for its management.

XI. DUTIES OF JOINT SECRETARY :

The Joint Secretary will assist the secretary.

XII. DUTIES OF TREASURER :

- i) To transact cash transactions, issue of vouchers and receipts.
- ii) To keep the bank account pass book, cheque book etc. to credit cash collected from time to time.
- iii) To maintain account books and all transaction records.
- iv) To accept donations, gifts extended to trust.
- v) Legal jurisdiction will be at Gulbarga, the trust may sue or be sued in the name of the trust.

BANKER AND BANK ACCOUNT :

The Bankers of the Trust shall be decided by the Board of trustees from time to time.

The Board of Trustees shall open a bank account in the name of the trust.

All money transaction with the bank shall be operated jointly and be signed by the President of Board of Trustees, and in his absence his nominee and the secretary of the trust.

INVESTMENT CLAUSE :

The funds of the trust shall be spent only to the attainment of the objects of Forum and no portion thereof shall be paid or transferred directly or indirectly to any of the member through any means. The funds of the trust shall be invested in the modes as specified under the provisions of Sec. 13(1)(a) read with Sec.11(5) of the Income Tax Act.1961 as amended from time to time.

ACCOUNTING CLAUSE :

The Trust will follow financial i.e. year beginning from 1st April and ending on 31st March of the succeeding year as its accounting year. The trust shall maintain regular and proper books of accounts of all receipts and expenditure of the trust and such accounts shall be audited by a chartered accountant as the defined under the Chartered Accounts Act, 1949 every year.

AMENDMENT CLAUSE :

However no amendment to the rule and regulation of the trust shall be made which may prove to be repugnant to the provisions of the Section 2(15), 11 to 13 and 80G of Income Tax Act as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.

DISSOLUTION CLAUSE :

In the event of dissolution or winding of the trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees/ members of the managing committee/ Governing body, but the same shall be transferred to another Charitable Trust whose objects are similar to those of this trust and which enjoys recognition under Section 80G of the Income Tax act 1961 as amended from time to time.

CLAUSE 5 : The trust formed shall be irrevocable.

CLAUSE 6 : The benefits of the trust shall be open to all irrespective of caste, creed or religion.

CLAUSE 7 : The funds and income of the trust shall be solely utilised for the achievement of its objects and no portion of it shall be utilised for payment to the trustees/ members by a way of profit, interest and dividends.

GENERAL :

1. All the deeds and other documents to be executed by or on behalf of the trust shall be done by the President or Secretary of the trust as per the Registration Act, Karnataka Stamps Act 1957 will be applicable in case of such documents. The trust may sue or be sued as per procedure laid down under the Act through its Secretary.

2. Powers not defined in this deed of trust are vested with the board of trustees in accordance with the existing applicable laws regulations, etc. that may be needed to transact the acts of the trust the come up before them from time to time.
